

# PYLE COMMUNITY COUNCIL

## MINUTES OF FULL COUNCIL MEETING

on

Wednesday 20 July 2011 in the Talbot Community Centre

The meeting commenced at 6.30pm

- 1. Present
  - a. Councillors; K John (Chair), L Ellis, P James, G Hooper, B Morris, M Rogers, D Williams.

- 2. Apologies for Absence.

- 3. Declaration of Interest in Accordance with Section 51 of the Local Government Act 2000 Any interest to be declared as items arise through the meeting.
- 4. Approval of Minutes.
  - a. The minutes for the meeting held on 29th June 2011 were approved. Proposed by Cllr G Hooper, Seconded by Cllr P. James. There were no objections
- 5. Business Arising
  - a. Bridgend Youth Council

Cllr P James made contact with a number of young people and requested the Clerk to inform them of the objectives of the Youth Council and the date of the next Council meeting. As a result of this the Clerk received an apology for them not being able to attend but would attend the September meeting

#### b. Members Reports

#### i. Reach

Cllrs P James reported that she and the Clerk attended a meeting of Reach a Rural Development Programme for a better rural Bridgend. At the beginning of the meeting a map was shown showing the communities included in the programme of which Pyle was excluded although all neighbouring communities were included. The classification was set in 2007 and although some Communities appealed and were reclassified no appeal had been made by Pyle. The next opportunity for re-classification is in 2013 for the 2014 round of grants. The clerk was asked to start the process.

#### ii. Bench at Woodland Park

Cllr James reported on a request for to replace the bench on the junction of Waunbant Road and Woodlands Park. Cllr L Ellis requested a vandal proof bench be installed. The Clerk was requested to obtain the necessary licence.

#### iii. One Voice Wales

Cllr B Morris reported he had received notice of a meeting to held in Cowbridge. Cllr Morris was unaware the One Voice Wales representative for this year was Cllr Ellis. The Clerk is to ensure One Voice Wales records are correct. The Clerk also reported on the notification of this meeting was received just two days before the meeting was to take place and he had written to draw the attention to the short notice.

Cllr G Hooper reported continued growing support and enthusiasm shown by many organisations for the Fun Day which, weather permitting should be an outstanding success.

c) The Clerk reported on the many conditions set by BCBC including; Risk Assessments, Insurance Indemnity, Hygiene Certificates etc.

## d) Bus Shelters

Cllrs A John, P James together with the Clerk met representatives of BCBC. Bus shelters will be provided at Heol Felig and Bridge Street it will not be possible to provide the proposed shelter at bus stop north of the traffic lights.

## e) Litter Bins

The clerk was asked to progress the installation of litter bins as previously requested. Cllr Williams referred especially to bins in Croft Coch and Cllr Morris referred to the returned problem of the litter left by school children after their lunch break the Clerk was asked to write to the head teacher
