## Clerk's Report

28th October 2015

Additional information to the agenda for the meeting being held on Wednesday 28th October 2015 at 7pm at Graig Community Centre, Bassaleg (**Item No 4 on the agenda**)

- 1. Play Areas** – The official opening of the Bassaleg green play areas took place on 6th October 2015 and work is also complete at Fort View. The toddler's play area behind Rhiwderin Community Centre is well under way, but no work is taking place at either the Caernarvon Drive or old Rhiwderin play area sites as yet. It is believed that the purchase of the old play area site is still being negotiated by NCC.
- 2. Coach House on Caerphilly Road in Bassaleg** - The Clerk is to arrange a meeting with the Coach House owner and Chairman of the Council when convenient to both parties.
- 3. Crash Barrier on Pentre Tai Road by Level Crossing** - This barrier has been inspected and deemed not fit for purpose. It's repair has been added to NCC's schedule of works.
- 4. Weed killing on Pentre Tai Road** - the area has been inspected and will be added to NCC's schedule of works.
- 5. Cycle Path by Bassaleg School** - signage for the cycleway is confusing or non-existent so NCC will paint signage onto the carriageway pending the dropping kerbs and the continuation of the red cycleway asphalt being installed.
- 6. Parking on grass verges on Laurel Road** - NCC have recently confirmed that they have passed this issue on to the Police who will determine what action should be taken. This issue will continue to be monitored.

### Unresolved outstanding issues being monitored

The following issues remain unresolved but will be monitored and any updates reported above.

- Adoption of footpath at the top of Highfield Lane
- Forge Road bus stop and lay by signage
- Former Garthfield Cottage site fencing and footpath
- Boundary fencing along Caerphilly Road between the Rhiwderin Inn and Laurel Road Junction
- Dog fouling signage
- Dedicated right turn into Laurel Drive
- Possible solar farm at Rhiwderin
