

GRAIG COMMUNITY COUNCIL

Minutes of the Planning and Environmental Meeting held at the Graig Community Hall Bassaleg 6pm on 12th December 2012.

1. Apologies for absence: Cllr K Harries, P Stokes, M Cornelious.

- 2. Public Representations: None.
- **3. Councillor Vacancy Interviews:** Interviews with 3 of the 4 prospective candidates took place, the 4th candidate having withdrawn. On conclusion of all interviews Council agreed that the calibre of candidates was very good and expressed disappointment that only one could be chosen. It was decided after discussion to offer the position to Victoria Cox-Wall. Clerk to advise candidates and invite Ms Cox-Wall to take up the position.
- **4. Minutes:** The Minutes of the meeting held on 14th November 2012, previously circulated were read and approved. Proposed Cllr Caston seconded Cllr Evans.

Arising from the minutes, Cllr Harris produced a draft of the memorial plaque for Cllr Rees to be placed on the new Jubilee Path.

5. Planning:

a. Draft supplementary planning guidance – Houses in multiple occupation (HMO's) 2012 - Cllr Ashton reported that the guidance was unlikely to affect housing in the Graig ward, but that the guidance given was confusing. It was not necessary to make comment as Graig would not be directly affected.

It was decided that the event planning would need to take place earlier in the year for next time, and that it would be prudent to set up a new Events Committee to be formed next May when Councillors are elected to boards and committees.
- c. National Assembly for Wales invitation to consult on the Local Government (Democracy) (Wales) Bill Cllr Caston agreed to review and bring back to January 9th meeting
- d. Letter from Burial Board Clerk Confirmation was received from the Burial Board Clerk that Mrs Vivienne Kelly had been appointed to the position of Clerk to the Rogerstone and Bassaleg burial Board, and thanked Council for the support given to her over the past years. Council wished Mrs Thomas a long and happy retirement. Cllr Harris reported that terms and conditions of employment for the new Clerk needed to be set, but should take place at a meeting without the new Clerk being present. Cllr Harris to contact the Chair of the Burial Board to arrange this.
