The Board has been strengthened by the addition of new Directors and has introduced e-banking. Carols at the Christmas Tree was again a successful community event. Some of the materials collected to produce the BVT Village History Book have been published on the BVT website. A monthly rota is in place for board members to monitor condition of trees, paths and litter and remedy where necessary. The Development Strategy 2012–2027 provides direction for the coming years with the immediate priorities to increase membership of Balloch Village Trust (currently approaching 60) and to finalise the Community Woodland Management and Improvement Plan. Initial discussions to involve the Forestry School in producing a Management Plan were not successful. The Board has requested a quote for the production of a Management Plan from a forestry professional who would act as a contractor and possibly as the project manager. IW (Chair, BCC) asked for details and intimated that BCC would consider making a contribution to the cost of the management plan. The BVT subgroup will consult BVT members on the priority issues raised in the Management Plan. BVT will then cost the work and raise funds.
