- **382.** Apologies for Absence Cllr R J Penny.
- **383. Declarations of Interest** None.
- **384. Minutes** of the meeting held on 9th March 2015, having been circulated, were approved and signed as a true record.
- 385. Matters Arising
 - a) Litter Pick. Minute 379 refers. The village litter pick held on 28 March 2015 had been well attended however insufficient supplies had been provided by Northumberland County Council. The clerk had spoken to the officers at NCC who advised that due to the number of taking place that weekend they had insufficient supplies. Mrs Senior advised that she had a supply of litter pickers and gloves should they be needed in future.
- **386.** County Councillor's Report. Cllr C Horncastle gave his verbal report.
 - **a) Polling Station.** Unfortunately, it had been too late to request a polling station in Hedley Village however this does not exclude Hedley from future elections. Residents who have trouble travelling to their polling station can request postal votes.
 - **b) Planning Review.** The recommend changes are going ahead although the committee structures are not in place yet but will be countywide. Possible changes to the area committee are being discussed although there is no detail yet. Further information to follow.
 - **c)** Resurfacing of footpaths. Cllr Horncastle requested specific locations to provide a quote for the resurfacing of the footpaths.
 - d) Sale of Council Buildings. NCC is currently in discussion with Queens Hall to see if the Queens Hall building can be used to accommodate visitor information and customer access in addition to the existing library. Such a move would allow the closure and sale of Hexham House, Prospect House, Hadrian House and the existing visitor information facility at Wentworth Car Park. Some staff working space may be provided at Queens Hall and further space may be developed as part of a comprehensive review of depot facilities.
- **Correspondence.** All correspondence since the March meeting had been listed on the agenda and was noted. All relevant items had been circulated to all councillors.
- **388. COMMUNITY ACTION NORTHUMBERLAND.** It was noted that the Spring Conference would be held on Tuesday 28th April 2015 at 2.00pm in Acklington Village Memorial Hall.
