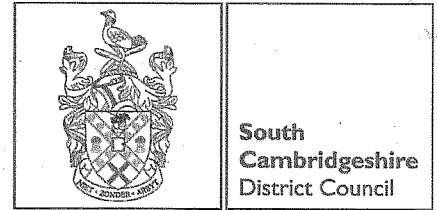

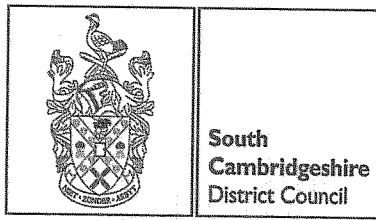

3. The positioning of the relocated sign does not cause any visual obstructions for either motorists or pedestrians
4. South Cambridgeshire District Council retains the right for the removal of the sign from its land, should the land in question be required for any other purpose in the future.
5. This letter constitutes Landlords approval only; If Planning permission may be required it is the individual's responsibility to ascertain the requirement.
6. If approval is required under the requirements of the Building Regulations and they can be contacted on 08450 450 062, to obtain the appropriate forms and fee details.
7. The proposed alterations are to be completed within 3 months from the date of this letter.
8. **That the enclosed postcard is returned on completion of the work in order that an inspection can be made.**

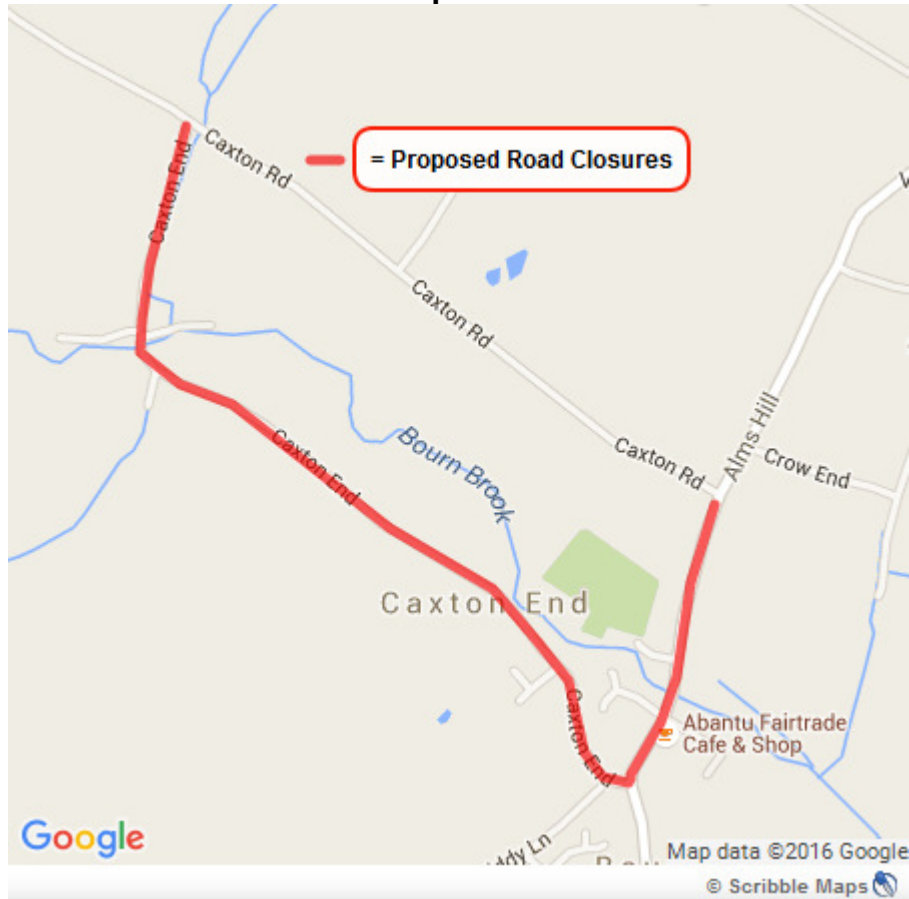

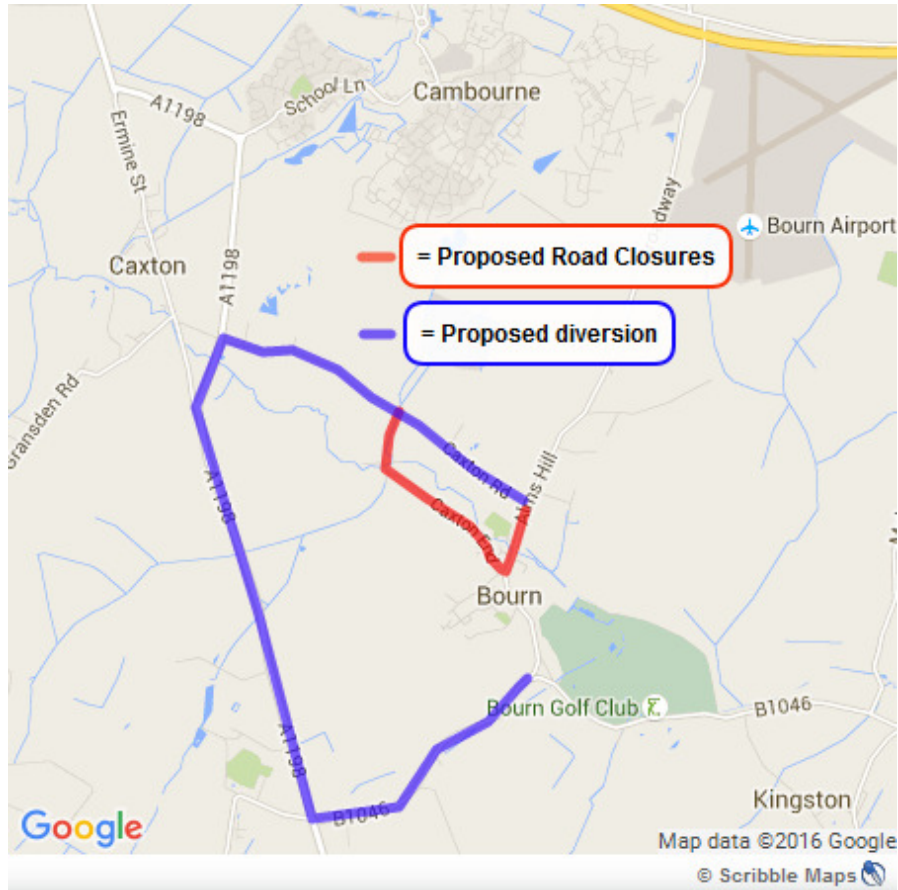
