- 3] MINUTES FROM PREVIOUS MEETING HELD ON SEPTEMBER 9, 2015 were accepted as circulated and signed by the chairman.

- 4] CLERK'S REPORT FROM PREVIOUS MEETING

5] CORRESPONDENCE

Notts County Council A606 Melton Road speed limit. The County Council advised the parish that it was not proposed to extend the length of the A606 road at Stanton to be covered by a speed restriction order but it was proposed to introduce a 50mph order on part of the road from Tollerton to Stanton not currently covered by any restriction.

Coun. Cottee reported that the County Council had approved the provision of one flashing speed sign and after discussion members agreed it should be sited on the road at the Southern end of the parish. The parish council would wait to see its effect before giving any consideration to the possibility of a second sign being provided for the northern side of the village, Currently Notts County Council say they can only supply one sign. If the parish wished to have a second they would have to meet the cost of £8600 for it. The meeting was also told by Coun. Cottee that money was being found for provision of a gateway system on the road at the southern end of the village.

Rushcliffe Borough Council advised of changes to planning arrangements. The clerk said he would be registering to the new scheme as soon as some initial problems at the Borough had been ironed out.
