#### **MINUTE No: 2/2/15 POLICE MATTERS:**

The Chairman welcomed the new PCSO Claire Quick to the meeting and wished her well in her redeployment to the area.

PCSO Quick outlined the current PACT priorities for the area and gave the following report:-

- There have been a number of anti social behaviour incidents in the vicinity of the Showcase Cinema
- A cannabis warning has been issued to one individual in the area, repeated offences could lead to prosecution proceedings being taken
- Two (2) vehicles have been 'seized' for not having appropriate insurance
- Criminal damage had been done to a property in North View. Inquiries in respect of this matter are ongoing
- Three (3) individuals have been taken into custody following a burglary in the area.
- Two (2) vans had been broken into on Moy Road Industrial Estate and tools taken
- There has been an attempted break in at Yr Hendre
- A West Highland Terrier has been stolen from a garden in Taff's Well, police were making further enquiries in respect of this matter.

#### 1. TEENAGE CANCER TRUST WALES

#### Resolved:--

That a grant of £250 be awarded to the Teenage Cancer Trust Wales

#### IT FACILITIES AT TAWELFRYN COMMUNITY CENTRE

At its last meeting Members agreed to support the "outreach programme" of the Taff's Well Community Development Project (THE HUB) by providing financial support to enable the Tawelyfryn Community Centre develop IT facilities for the local community.

It was agreed that the Council would provide three (3) computers and a printer at a cost of approximately £1500 and requested that estimates be sought to supply these items.

The Clerk confirmed that final estimates have now been received and the costs had risen slightly to £1643.02. Members were therefore requested to note and approve the additional expenditure.

In addition, the Clerk reported that BT has now confirmed a quote for their telephone and broadband package at a cost of £114 for a new line and six a (6) months free for the router, normal cost £8 per month. Members are requested to note and approve, on receipt of invoice, this expenditure

#### Resolved:-

Members noted the above report and approve the expenditure.

#### **MINUTE No: 6/2/15 MEMBERS' REPORTS**

#### **Cllr Megan Jones**

• Expressed concern about the poor state of the embankment in Brynau Woods the pathways leading through the woods were very difficult to negotiate owing to parts of the embankments 'slipping' when there was heavy rain. The member asked if it was possible for the County Council to re-enforce the embankments. Councillor Bonetto agreed that she would contact the appropriate officer to see what could be done.

#### **Cllr Sandra Lintern**

• Informed Members that she had received a number of complaints about the anti social behaviour of a resident residing on Yr Hendre, Nantgarw. The tenant appears to be using the property as a commercial enterprise 'repairing damaged vehicles' and causing noise and distress to neighbouring properties. In addition, there have been complaints that the embankment outside of the neighbouring properties has been extensively damaged as the tenant has taken to towing/winching vehicles into his garden. It was agreed that the Clerk would contact RCT Homes and make a formal complaint in respect of this matter.

### **Cllr Mel Timothy**

In her absence the Member had emailed asking that the following items be raised at the meeting

- A mother had telephoned complaining that the park in Tawelfryn is unsafe. Her daughter had fallen in the park itself and cut her leg, the parent claimed that the ground by the climbing frame is uneven. The parent emphasised that she did not want to make an insurance claim but would like the problem rectified. It was agreed that the Clerk would pass on the item to the parks department.
- Asked if a sign could be erected, as you come into the Tawelfryn estate, letting people know where the community centre is? It was agreed that the Clerk would send a copy of the email to the County Member
